### **Power Golf Cart Rental Agreement, Including Assumption of Risk & Agreement Not To Sue**

This agreement shall apply to all rentals of golf carts provided by the Royal Regina Golf Club (herein "the Club") and/or the golf professional retained by the Club to provide professional golf services (herein "the Professional") to members of the Club. In consideration for the rental of the golf cart provided by the Club and/or the Professional, I agree to the following conditions:

1. I am familiar with the safe operation and use of the golf cart and any other instructions provided to me regarding the golf cart, including any policies pertaining to the proper use of golf cart on property of the Club and on adjacent roadways, and will operate the golf cart in accordance with said instructions and policies.
2. I agree to contact the Club and/or the Professional if I have any questions or concerns about operating the golf cart.
3. I agree that only persons who are 16 years or older shall be permitted to drive the golf cart. I further agree that I will not authorize anyone who is not familiar with the safe operation and use of the golf cart and any other instructions provided regarding the golf cart, including any policies pertaining to the proper use of golf carts on property of the Club and on adjacent roadways to operate the golf cart.
4. I will operate the golf cart safely and responsibly, and I will preserve and protect the golf cart from loss or damage to the cart itself, my person or property, and the persons or property of others.
5. I agree that the maximum occupancy of the golf cart is two persons, including children.
6. I agree that if I sign this form it means that should I be injured or killed for whatever reason while riding in or driving a golf cart, I cannot sue the Royal Regina Golf Club, its Officers, Directors, Employees, Volunteers, or Members or the Professional. I agree to this for not only my first golf cart rental, but also for any golf cart rentals I may make in the future. I agree to hold harmless, defend and indemnify the Club and/or the Professional for any and all damages and claims of any nature whatsoever that may arise from the use of said golf cart by myself or others authorized by me, including but not limited to claims for damages to the golf cart itself, my person and property and the persons and property of other I further agree to reimburse the Club and/or the Professional for any unrecovered costs, including but not limited to deductibles and any uninsured losses.
7. In the event that I violate any of the above conditions, I agree that the privilege of using the golf cart can be revoked without notice by the Royal Regina Golf Club and/or the Professional in their sole discretion. I further agree I shall not be entitled any rental refund for such revocation of privilege, and acknowledge that the privilege of future use of a golf car on the property of the Club may be suspended or revoked.
8. I agree that this Golf Cart Rental Agreement is made with the Club and the Professional and is in effect for all golf cart rentals until cancelled in writing by me or by the Club or by the Professional; provided, however, that clause 6 hereof shall survive cancellation for any damages or losses occurring while this agreement was in effect.
9. I certify that I understand and agree to the conditions set forth above. I acknowledge that I have signed this document voluntarily and freely and that my signature creates a contractual obligation that binds me, my heirs and successors.

## Parental Consent For Junior Member Charging Privileges

### CREDIT POLICY:

- Charging privileges in the Pro Services and Restaurant can be extended to Unattached Junior Members providing we have a credit card on file. Accounts must be monitored by their parent and paid on the monthly basis. Junior Members are limited to \$500 in current credit.

Members are required to provide a valid credit card to the RRGC to secure credit. The credit card will only be charged if payments on the member's account are more than 59 days overdue.

- In the event that the credit card on file is invalid, members who have not paid their account within 59 days, that is, prior to the end of the following month of their last month-end statement, may have their credit privileges suspended until their account is current.
- Interest will be charged on accounts overdue more than 30 days at a rate to be determined from time to time by the RRGC.
- Members whose accounts are overdue by more than 90 days may have their golf and clubhouse privileges suspended until the account is current.
