CREDIT POLICY

9.10 Credit Privileges, Requirements and Restrictions – Members

Policy:

- a) accounts are due on receipt of the monthly statement
- b) a member shall be limited to a maximum of \$2500 in credit
- c) an Intermediate member shall be limited to a maximum of \$1000 in credit
- d) to secure credit a member must provide a valid credit card to the Club which shall be retained on file by the Club
- e) charges to a member's credit card on file shall be made only where a member's account is overdue by more than 30 days past the statement date where the member's account became in arrears, and this will be applied without notification to the member.
- f) in the event that the member's credit card on file with the RRGCC is invalid or becomes invalid, and the member's account is more than 30 days overdue, the member's credit and charging privileges, as well as golf privileges may be suspended until the member's account is current
- g) interest of an amount set by the Board of Governors from time to time shall be charged on all accounts overdue more than thirty (30) calendar days past the statement date
- h) where a member's account is overdue by more than sixty (60) calendar days past the statement date that the account became in arrears, the member's golf and clubhouse privileges may be suspended until the member's account is current
