Parental Consent for Junior Member Charging Privileges

- Charging privileges in the Pro Services and Restaurant can be extended to Unattached Junior Members providing we have a credit card on file. Accounts must be monitored by their parent and paid on the monthly basis. Junior Members are limited to \$500 in current credit.
- Members are required to provide a valid credit card to the RRGC to secure credit. The credit card will only be charged if payments on the member’s account are more than 59 days overdue.
- In the event that the credit card on file is invalid, members who have not paid their account within 59 days may have their credit privileges suspended until their account is current.
- Interest will be charged on accounts overdue more than 30 days at a rate to be determined from time to time by the RRGC.
- Members whose accounts are overdue by more than 90 days may have their golf and clubhouse privileges suspended until the account is current.
